Hereby represent and warrant to the Company: JAMENDO S.A., 76 Avenue de la Liberté in L-1930 Luxembourg, hereinafter referred to as "Jamendo"

I also represent and warrant that, in accordance with Clause 3.1.3 of said terms:

None of the writers or performers that contributed to the works digitised on the Jamendo website in my above-mentioned name are a member, in any country, of any performance rights organisation, whether as a writer/composer, performer or record producer¹;

to waive my rights to receive payment of royalties for copyright and/or related rights and therefore to claim any payment of royalties from any of the relevant performance rights organisations, in any of the countries involved during the term of the Agreement with Jamendo.

In the event that I register for the commercial programmes offered by Jamendo Pro, I undertake to share any sums paid into the Artist Account between the relevant rights holders.

I undertake on my behalf and, where applicable, on behalf of the rights holders that I represent, not to exclusively and/or retroactively entrust the royalties for any works provided to Jamendo Pro to any performance rights organisation during the term of the Agreement with Jamendo, and as regards any period covering all or part of the period during which I am contractually bound to Jamendo.

Accordingly, I hereby agree to hold Jamendo harmless from and against any claims in this respect.

I am aware that this declaration may be used as evidence in the event of a dispute and that should I have made any false declarations, I will be liable for the reimbursement in full of any sums that Jamendo may be required to pay on account of any false declaration.
